## Momentum of price changes to ease: RBI bulletin

But elevated inflation levels warrant appropriate policy responses

Mumbai, August 18 Inflation has edged down, but its persistence at elevated levels warrants appropriate policy responses to anchor expectations going forward, according to the Reserve Bank of India's latest

monthly bulletin. The provisional data released by the National Statistical Office (NSO) on August 12 shows inflation, measured year-on-year (y-o-y)changes in the all-India consumer price index (CPI), eased to 6.7 per cent in July from 7 per cent in the previous month.

#### **Heartening development** "Perhaps the most heartening development in recent times has been the easing of inflation in July 2022 by 30

basis points from June 2022 and an appreciable 60 basis points from the average of 7.3 per cent for Q1 (April-June), 2022-23.

"This has validated our hypothesis that inflation peaked in April 2022. For the rest of the year, the RBI's projections scent a steady easing of the momentum of price changes," said 28 RBI senior and top RBI officials, including Deputy Governor MD Patra, in an article "State of the Economy".

With the trajectory of outcomes largely in line with

projections, the officials expect momentum of price changes to ease. The authors noted that if these expectations hold, inflation will fall from 7 to 5 per cent in Q1 next financial year - within the tolerance band, hovering closer

to the target, but not yet po-

sitioned for landing. This is a

decisive

point in

trajectory. "Imported inflation pressure points remain the overarching risk, followed by pending pass-through of input costs if producers regain pricing power, and wages. Yet, some risks have turned down - commodity prices, especially of crude; supply chain pressures; revving up of monsoon activity due to the depression in the Bay of Bengal," the officials said.

The authors observed that after Q1-FY24, the task before the Monetary Policy Committee (MPC) would be to guide inflation to its target of 4 per cent. This may prove to be more arduous than the loss of height into the tolerance band, they added.

#### India, preferred destination

The RBI officials termed the return of capital flows to India after a hiatus, when the appetite of portfolio flows to **Emerging Market Economies** deteriorated as the US dollar appreciated breathlessly with the US Fed accelerating its hiking cycle, as a heartening development.

They underscored that India is becoming a preferred destination for portfolio flows - in August so far (until

#### 'NBFCs need to be wary of rising borrowing costs

With normalisation of monetary policy, non-banking financial companies (NBFCs) need to be careful of the rise in their borrowing cost, says an RBI article.

The non-banking lenders are poised for an expansion aided by strong capital buffers, adequate provisions and sufficient liquidity on their books, the article 'A steady ship in choppy Waters: An analysis of the NBFC sector in recent times' said.

It is prepared by Rajnish K Chandra, Nandini Jayakumar, Abhyuday Harsh, K M Neelima and Brijesh P in the division of Non Banking Financial Studies, Department of Economic and Policy Research of RBI.

"Going forward, as the economy recovers, NBFCs need to be wary of rising borrowing costs on account of normalisation of monetary policy," the article published in the RBI's monthly bulletin for August said.

Since May this year, the RBI has raised the policy rate by 140 basis points to tame inflation which is hovering above its tolerance band of 4-6 per cent. Following these hikes, banks have raised their lending rates, which resulted into higher borrowing cost for borrowers. The authors said while NBFCs have largely realigned their business models by leveraging digital channels to improve their accessibility and acquisition of new customers, this might prove to be a challenge for smaller NBFCs which may have to ramp up their technological capabilities.

## 'More nuanced approach required for privatisation of PSBs'

A big bang approach of privatisation of public sector banks (PSBs) may do more harm than good, cautioned an article in the Reserve Bank of India's latest monthly

Referring to the government's intention to privatise two banks, the authors of the article said: "Such a gradual approach would ensure that large scale privatisation does

not create a void in fulfilling important social objectives of financial inclusion and monetary transmission."

"From the conventional perspective that privatisation is a panacea for all ills, the economic thinking has come a long way to acknowledge that a more nuanced approach is required while pursuing it," said the central bank officials - Snehal S. Herwadkar, Sonali Goel and Rishuka Bansal, in the article

### Non-resident without permanent establishment in India not liable for TCS

Exemption will also help tour operators selling overseas tour packages

New Delhi, August 18 The Income Tax Department has said that the provision related with Tax Collected at Source (TCS) will not be applicable on buyers who are non-resident Indians (NRI) and not having permanent establishment (PE) in India. This will also help tour operators selling overseas tour packages to such non-resident

The Central Board of Direct Taxes (CBDT) has notified the exemption with effect from August 17. It will suppress previous notifications issued in March this year. Income Tax Act defines nonresident Indian as an individual, being a citizen of India or a person of Indian origin but who is not a "resident". Further, an individual is said to be resident in India in any previous year, if he is in India in that year for a period or periods amounting in all to one hundred and eighty-two days or

TCS and TDS are two means for collecting income tax on transaction. While in TCS, it is the responsibility of the receiver to collect tax and deposit it with the government, TDS rules implies tax to be deducted by the givers and deposited with the government. #### **Exclusion provided to NRIs**

Services of domestic tour operators whose services were increasingly being used by non-residents faced the dilemma of collecting such TCS and administering provisions of this section, and meanwhile, the non residents faced the dilemma of dealing with the inability to claim credit for TCS since they had no obligation to file tax returns in India. Accordingly as part of post pandemic relief a notification was issued on March 31, 2022 providing exclusion to non-residents visiting India.

"Now with August notification, issued in suppression of the earlier notification, the scope of exemption has been broad based to also exempt collection of TCS from non-residents who do not have a PE in India, which could include corporate and professional firms who were availing of such services," Srivatsan explained.



#### **Govt hikes** windfall profit tax on diesel export

PTI, NEW DELHI: The government on Thursday hiked the windfall profit tax on the export of diesel to Rs 7 per litre and brought back a tax on jet fuel exports, but slashed the levy on domestically produced crude oil in line with softening rates.

At the third fortnightly review, the govt raised the windfall profit tax on the export of diesel to Rs 7 per litre from Rs 5 a litre and brought a Rs 2 a litre tax on ATF exports, a finance ministry notification showed.

Earlier this month, the government had scrapped the windfall profit tax on ATF (Aviation Turbine Fuel) exports.

Alongside, the tax on domestically produced crude oil has been cut to Rs 13,000 per tonne from Rs 17,750.

The tax on exports has been raised as cracks or margins rose but the same on domestically produced oil was reduced as international oil prices slid to a six-month low.

India first imposed windfall profit taxes on July 1. But international oil prices have cooled since then, eroding profit margins of both oil producers and refiners. On July 1, export duties

of Rs 6 per litre (USD 12 per barrel) were levied on petrol and ATF and a Rs 13 a litre tax on the export of diesel (USD 26 a barrel). A Rs 23,250 per tonne windfall profit tax on domestic crude production (USD 40 per barrel) was also levied.
