## Palm oil at 18-day high on stronger rival oils, crude



# Bet short in natural gas

In the last couple of weeks, natural gas prices rallied sharply. Consequently, the futures contract of this energy commodity on the Commodity Exchange (MCX) rallied after taking support at ₹500. Notably, the December series marked a high of ₹667 last week before falling to the current level of ₹592.

Thus, the contract could not complete a weekly close above ₹600, which is a strong resistance.

We expect natural gas futures to decline from the current level where it could touch ₹500, a support. Subsequent support is at ₹475. On the other hand, if the contract recovers and gives a daily close above ₹630, the trend might turn in bulls' favour. Above ₹630, it could retest the prior high at

# TRADE STRATEGY

Considering the above factors, traders can risk going short on the MCX-Natural gas futures (December contract). That is, short the contract at the current level of ₹592 and add more shorts when price rallies to ₹615. Place initial stop-loss at ₹642.

When the contract falls below ₹550, revise the stoploss down to ₹585. Liquidate all the shorts at ₹500 because there could be a bounce off this support.

# Going against grain, Telangana farmers sow cotton in rabi season

**WORD OF CAUTION.** Scientists against large-scale farming as bollworm may get free ride

N Venkatappa, a farmer in Vathugundla village in Narayanpet district of Telangana, usually grows groundnut as the second crop after growing pulses in during the kharif

But this time around, he wanted to try cotton. "I have a borewell and assured irrigation. My decision has triggered a huge interest among fellow farmers," he said.

With increased irrigation facilities in the State after its formation in 2014, Venkatappa, along with hundred other farmers in the State, have decided to grow cotton during the rabi season for the first time in the country.

Scientists, however, have raised the red flag cautioning

farmers against cultivating the fibre crop during the winter season for two key reasons - it allows pink bollworm to survive and carry on until the start of the kharif cotton and poor yields due to punishing temperatures if the flowering takes place around February.

large-scale cultivation. The Indian Council of Agricultural Research (ICAR), too, has asked the university not to encourage the farmers to cultivate cotton during the rabi

"It should be conducted only in areas where assured irrigation is available. The cultivation should be done on a small scale. They would require 12-15 irrigations to sustain the crop," he said.

Keshav Kranthi, head of technical, International Cotton Advisory Committee, echoed a similar view. "It is okay if it is being done on an experimental basis," he said.

"One major concern is the potential of rabi paddy crop to carry over pink bollworm into the main crop in kharif," said Kranti, former Director of Central Institute for Cotton Research.

The kharif rice crop might be lower than the Ministry of Agriculture's first advance estimates. According to the estimate, rice production is pegged at 104.99 million tonnes (mt) against 111.76 mt last year.

This year, kharif paddy cultivation was affected by deficient rains in eastern Uttar Pradesh, Bihar, Jharkhand, Odisha and West Bengal. Chandrasekaran said a clear picture of kharif rice production will be available by December-end. The export-import firm official said it will be January to get clarity on the

"The crop may not be as low as feared," he said.

"We are not getting any significant enquiry or orders, particularly to South-East Asia," said M Madan Prakash, President, Agriculture Commodity Exporters Association.

# Congress submits memo to SP Traffic

PANJIM: A delegation of North Goa District Congress Committee on Tuesday urged the Traffic Police to take strict measures to ease movement of vehicles by reducing illegal use of no parking spaces and to come down heavily on unlicenced private vehicles used as taxis as well those found teaching driving to spouses and relatives by using rent-a-cab or rent-abike on public roads.

In a memorandum submitted to SP (Traffic) Bossuet Silva, the delegation said that the people of Goa have to bear the brunt of increasing instances of traffic snarls faced in various parts of the State. The recent traffic block at the Cortalim side across the Zuari River, which held motorists for hours is a pointer to what could become even worse in the days to come.

Beginning with Panjim, the delegation pointed out that

the government authorities were dumping projects after projects causing traffic chaos every day. The perennial trouble spots along the D B Road where the Captain of Ports has granted permission for use of ferry ramps and jetties for use by off-shore casino operators are causing avoidable snarls every day and night too.

The traffic cell must take a call about strict enforcement of no parking along D B Road and increase the fines imposed on errant drivers who tend to break the rule of no parking with impunity. The reckless digging of roads carried out by various authorities has added to the problem, they said.

The delegation also requested the traffic police to review NOCs if any, granted to new proposals for new projects such as development of former 'quarterdeck' land opposite Hotel Mandovi, proposed ropeway at Campal as well as tendency to build jetties.
